RESOLVED: To receive apologies of absence for this meeting

2/2024 Chairman's Welcome

Welcome to first PC meeting of 2024. Priority for this meeting is to set the level of Precept for CEPC for 2024/25.

3/2024 Declarations of Interest

RESOLVED: that the following declaration of interest under consideration on this agenda in accordance with the Localism Act 2011 s32 and under The Relevant Authorities (Shropshire Council disclosable Pecuniary Interests) Regulations 2012 was received:

4/2024 Public Question Time and Participation

None. Chair, Councillors and Clerk introduced themselves to the two members of the public in attendance, giving an overview of the work of the PC.

5/2024 Minutes

RESOLVED: To accept the minutes from the Parish Council Meeting held on 20th December 2023 as being correct.

6/2024 Matters arising/action taken from the Minutes not otherwise included in the agenda. None.

7/2024 Safety in the Parish

No issues reported.

8/2024 Highways and footpaths

a. Update on Crow Lane Weight Limit

Work has begun by SCC on site, and PC have been advised that it should be complete end of January, early February. Parish has been notified of a road closure to complete. PC discussed forming a community group to monitor if signage is ignored.

b. Other safety enhancements

Chair continuing to follow up with Cllr. Gittins the potential for VAS/SID (speed indicator devices) on the section of the Eaton Road from the entrance to the Hall to the club junction, which has no footpath, and is the main thoroughfare to the playing fields and Hall. Chair to contact SALC to confirm that the PC can use CIL money for them and if so, next step is to meet Highways on site. Potential cost of £5,000 (for both) plus posts for solar devices. There might be potential to part fund by way of the Safer Roads Fund held by the Police and Crime Commissioner.

c. A41 working group – updates on new cross county group.

No further update.

d. Footpaths – to consider any queries which may impact on the parish.

No issues reported.

e. Streetlights.

Chair continues to chase EON to repair lamp outside No 4 St Michaels which is broken. First advised in November. Replacement of remaining bulbs paused noting potential fence costs. PC discussion to consider dark sky bulbs.

9/2024 Parish Matters

a. Land Transfer – update on land registration.

Chair to continue to monitor with the item staying on the agenda until completion.

b. Airband - FTTP roll out in the parish.

Nothing further to report. Item to stay on the agenda as FTTP (Fibre to the Premises) or Gigabit Rollout.

c. Trees – Tree Preservation, planting, and maintenance.

Childs Ercall Hall – Application made to SC undertake tree cutting and felling.

Cllr. Clifton will check on the platinum trees with a view to whether they will need replacing in the spring.

10/2024

Grounds Maintenance/Playground

a. To receive an update from the grounds sub-committee.

Grounds maintenance looking at the costs for a new path (stepped out from the trees) from the gate to the Hall/playground to include lighting. Initial quotations obtained for various options for a new path – cheapest option is to relay the existing paving slabs away from the trees. More costlier options are a new tarmac or resin path. Additional quotes to be obtained.

Grounds maintenance looking at the costs of replacing, all, or part of the chain link boundary fence along the southern elevation (under the trees), which is damaged and is at the end of its useful life. First estimate for replacement/repair of the fence has been obtained for a complete replacement of the fence (215 mtrs) with mesh and new posts. Cllr. Hatfield to obtain further quotations.

Grounds maintenance/chair to organise a localised repair to the hedge/post and rail fence along the Eaton Road, where there is currently a gap.

RESOLVED: Ground maintenance to progress the repair to a maximum cost of £200.

b. Playground – to receive the monthly inspection report.

Cllr. Barnes provided the maintenance report, with no issues reported.

Cllr. Barnes is taking a review of the playground and warranties and is liaising with Kompan to understand best practice and warranty timescales.

11/2024 Parish infrastructure projects - Community Plan

a. Community and Place Plan.

b. Improvements to the village green/bus stop – picnic benches and bike rack.

Picnic benches delivered into temporary locations. PC to confirm where these should be positioned permanently and remove the existing bench. Bike rack delivered, requires fitting into position.

c. Improvement to the playing fields - commitment to football pitches, path and boundary fences.

Noted July 2023 minute commitment to pay for, or fund re-sizing, of goal posts. Chair advised that both pitches would require goal posts for September 24. For review with football groups. Potential for clubs to apply for PC grant.

d. Sport England Grant Application.

Sport England Grant Application considered at last meeting put on hold until financial position regarding the repair to the boundary fence is concluded.

e. Nature trail (between the trees adjoining the playground), tree planting and conservation.

No further discussion. Item to remain on agenda.

f. Rural bus services – North Salop Wheelers – currently in Cheswardine, Hinstock and possibly Stoke-on-Tern. Potential subsidy.

Service will continue to be advertised in the parish, despite interest there has been no applicants. PC will continue to monitor and if there is interest a donation will be considered at that time.

Website continues to be well used. Facility to link to SC Planning Portal has been added to the subscription. There is an opportunity to include an 'Events' channel to further promote village events. Cllr. Barnes to liaise with the village organisations and update.
